**VOTER REGISTRATION REQUIREMENTS**

- Must be a United States Citizen.
- Must be a Florida resident.
- Must be 18 years old (you may pre-register at 16 or 17, but cannot vote until you are 18).
- If you have been convicted of a felony, or if a court has found you to be mentally incapacitated as to your right to vote, you cannot register until your right to vote is restored.

**CURRENT RESIDENTIAL ADDRESS**

F.S. 101.045: A person is not permitted to vote in any election precinct or district other than the one in which the person has his or her legal residence and in which the person is registered. However, a person temporarily residing outside the county shall be registered in the precinct in which the main office of the Supervisor is located when the person has no permanent address in the county and it is the person’s intention to remain a resident of Florida and of the county in which he or she is registered to vote.

**REGISTER TO VOTE**

In order to vote, citizens who will be 18 years or older by Election Day must register in the county they reside in. A voter remains registered as long as he or she is an active voter.
